This Agreement, effective the date of execution, by and between NEOSHO COUNTY COMMUNITY COLLEGE, Chanute, Kansas ("NCCC") and SEWARD COUNTY COMMUNITY COLLEGE/AREA TECHNICAL SCHOOL, Liberal, Kansas ("SCCC/ATS").

WHEREAS, effective on July 8, 2010 NCCC and SCCC/ATS entered into an Agreement For Neosho County Community College Health Information Technology (HIT) AAS Degree With Seward County Community College/Area Technical School (the "HIT Agreement"); and

WHEREAS, the undersigned parties desire to ratify, confirm, and amend the terms of the Agreement.

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the parties agree as follows:

1. NCCC and SCCC/ATS hereby adopt, ratify, and confirm the HIT Agreement in all of its terms and provisions, and both parties wish to continue with the Agreement.
2. The parties agree that effective for Fall Semester 2016 and thereafter the terms of the HIT Agreement are modified as follows:
 - 2.1 Curriculum. The attached curriculum information sheet shall replace the sheet attached to the original HIT Agreement.
 - 2.2 No Partnership or Joint Venture. Notwithstanding any language to the contrary, the HIT Agreement and this Ratification And Amendment do not create a partnership or joint venture between the parties.
3. All other terms not modified hereby remain unchanged and in full force and effect.
4. The Agreement shall extend to and be binding upon the representatives, successors, and assigns of the respective parties hereto.
